## **Reduction of Barriers Policy**

Updated November 2023

## I. Policy Statement

Burlington Force Soccer Academy (BFSA) is committed to fostering an inclusive environment that provides equal opportunities for all individuals who wish to participate in our programs, regardless of their background or circumstances. We believe that soccer is a powerful vehicle for positive change, personal growth, and community development and recognize that certain barriers may impede potential participants from fully engaging with our Academy. This policy outlines our commitment to reducing these barriers through proactive programs, partnerships, and other mechanisms.

#### II. Identification of Barriers

BFSA acknowledges that barriers to participation can take various forms, including but not limited to:
